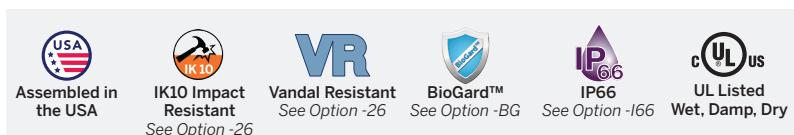

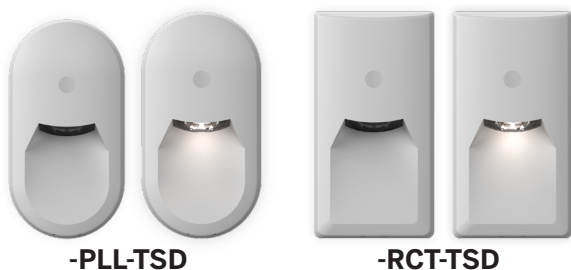

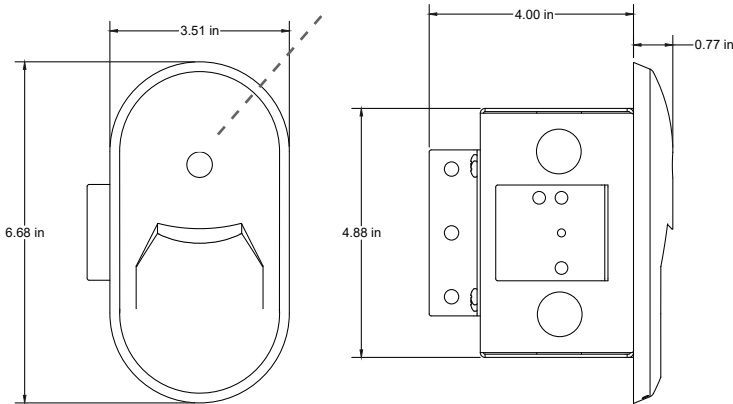
Touch Sensitive Dimming Switch



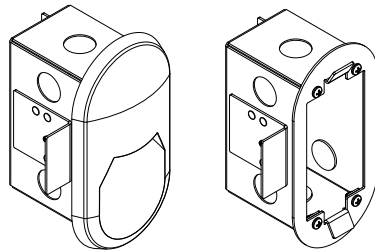
With option TSD, the Hitsville task light is controllable by human touch. Tapping the switch will turn the task light on (at the previous light level) or off. Holding the switch will continuously dim the task light down to 1% output, and then cycle back up to 100% output.

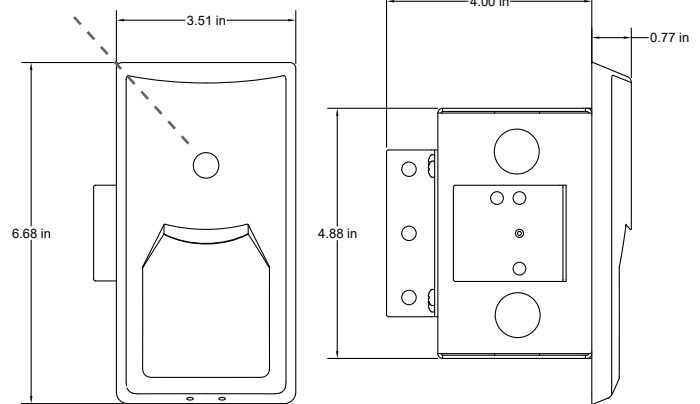


Oval Task Light

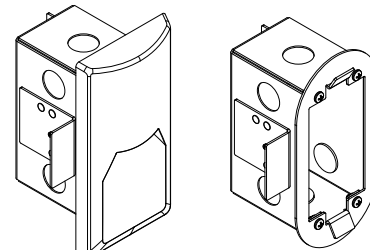


Shown with Option -26 wall bracing.

Rectangular Task Light

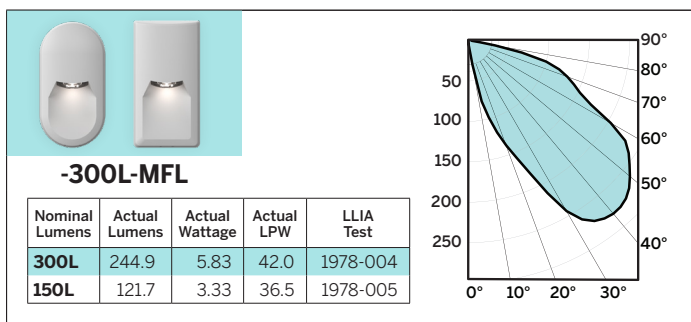
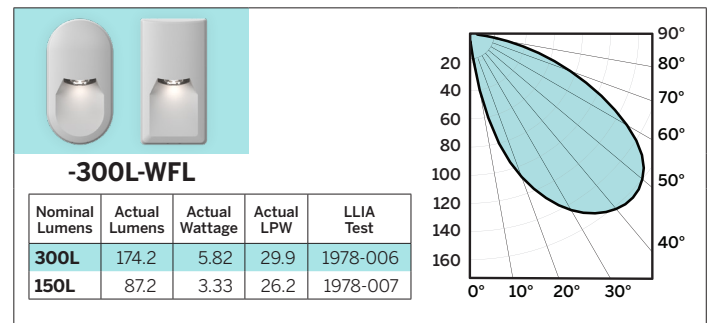
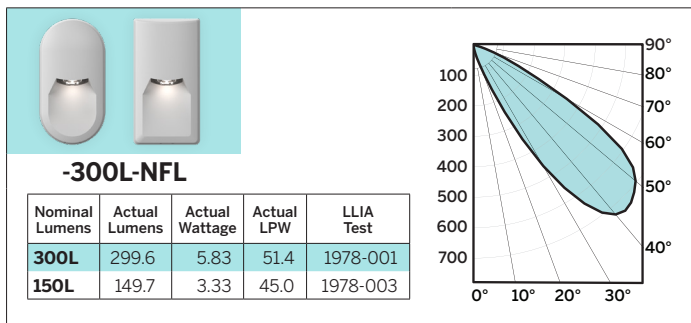
